INDEMNITY / WAIVER OF LIABILITY

This form provides for the furnishing of particulars of participants in chapter rides and every person who furnishes his or her particulars and signs thereby declare, by doing so, the following:

1. That he or she fully acknowledges and understands the risks and dangers inherent in motorcycling, voluntarily participates in the ride and expressly agree to assume the entire risk of his or her participation;
2. That he or she understands and accepts that the ride, whether it is part of an event or not, or in the event of it being a marshalled event or not, shall be under the control and direction of the LOH officer appointed for the ride, understands and accepts the manner in which the Marshals' Corps of the Pretoria Chapter rides and agrees and consents to the marshalling of the ride as provided for in the Marshals' Rules (the Marshals' Rules which form part of the By Laws of the Pretoria Chapter are available for perusal)
3. That he or she releases and holds harmless the Pretoria Chapter of the Harley Owners Group and its respective officers, directors and member of its Marshals' Corps from any claims which such person has or may later have relating to his or her person or property, whether or not such claim results from negligence (except gross negligence and wilful intent) on the part of any or all of the released parties or from the conditions, qualifications, instructions, rules or procedures under which the ride is conducted or from any other cause, including the imposition of fines;
4. That he or she understands that the above means that they agree not to sue any or all of the released parties for any damage to themselves or their property arising from or in connection with the ride, except in the case of gross negligence or wilful intent by any of the released parties.
5. If a minor is to participate in the ride, then the person signing on behalf of the minor, by furnishing particulars and appending a signature, further agrees to take responsibility for the minor's participation in the ride and consents to this release and waiver of liability on behalf of the minor.
6. That all photos taken on the day might be used for advertising and marketing purposes for the H.O.G.®Pretoria Chapter.
